## **FINANCIAL POLICY 2025-2026 [NEW]**

### **GRADE 1-3**

1. The following non-refundable investments are required :

1.1	CAPITAL FEE (One Time Only)	—————→	4,950,000 Ar
1.2	RE/REGISTRATION FEE	—————→	350,000 Ar
1.3	BOOK FEE	—————→	80,000 Ar

2. Method of Payment :

2.1. Payments for the non-refundable fees are due during enrollment.

2.2. Payment for the first month's tuition fee must be paid during the enrollment or by the first week of the new school year.

2.3. Parents will be billed during the last week of every month for tuition fees for the following month – payable in advance. Payment must be done no later than the fifth of the month.

2.4. 5% discount is offered to all parents who pay the annual tuition fees in advance. The payment must be done during enrollment or by the first week of the new school year.

2.5. A late fee of 50,000 Ariary will be added to the tuition if payments are late and/or after the tenth of the month.

2.6. Please pay by cash, cheque and bank transfer not postdated cheques.

3. Loss or Damage to Property :

Should a student be found responsible for the loss of or damage to property of the school or any other party, whether accidentally or deliberately, the parent/sponsor shall be held liable for payment or replacement of said property.

4. Non-refundable policy:

All payment received in advance will not be refunded if the child is removed from school.
